Bedford High School Alumni Association Accomplishments and Goals (July 2008)

When the association was formed in 1996, the primary purpose was to be the sponsoring organization for the Bedford Community Stadium Project. The secondary purpose that spun off the original was to encourage and promote camaraderie between all Bedford High School Alumni.

The Stadium has been built, and has been operating since the fall of 1997. We have an Alumni Association web site page on the Bedford Public Schools Website, and it is a most sought after place to post reunion information. We also have stadium information there as well. Working with Harris Connect, an Alumni Directory is published every 5 years and a database of this information is on file with the association. People contact us all of the time for information on lost classmates and for a copy of the database as it pertains to their particular class year to help them at reunion time. Harris Connect also maintains a web site where alumni can update their information and receive information as well. The two original purposes of the organization have been met, and beyond.

The Stadium Project was originally scheduled to be done in three phases, as funds would allow. The first stage was the completion of the field and spectator areas, and while it opened in 1997 with a little work to be finished, this part was completed in 1998. Bathroom facilities were portable restrooms and portable hand washing stations, and remain that way today. Concessions were prepared off site, and were sold from tents and tables inside the facility.

The second phase was to be permanent concession stands, and that was taken on by our Band and Orchestra Booster Organization. Three concession stands of outstanding quality were built using local contractors where necessary and volunteer labor wherever possible, and the stadium patrons are served well with a very reasonable wait time because of them. The Band Boosters make the payments on their loans from the profit made on the stadium concessions.

The third phase of the project was to be permanent restrooms and locker room areas under the home and away stands. This part of the project has not been accomplished yet, and will in all likelihood remain uncompleted until financial conditions improve. We have not had any other organization step up to date, and the Alumni Association simply cannot take on any more major financial commitments until the original stadium loan has been retired.

The stadium had been an overwhelming success in our community. Not only does it provide a premier venue for our football and track teams to compete in, it also has been a blessing for the community at large. Most evenings you will find area residents running or walking the track. Sometimes people will simply sit on the bleachers, reading in the sun. The Relay for Life of the American Cancer Society has been a huge success at the stadium, and everyone who participates is impressed by the facility. Gym classes from both the Junior and Senior High Schools have used it in the past, and the list of uses goes on and on. The Senior Relays, Junior and Senior Girls Big Ball Game, Bedford Township Fireworks Display, and Elementary Schools Field Days are all hosted at the stadium. Bedford Community Stadium is also the home of The Toledo Reign, a local women's professional football team.

There is absolutely no question that Bedford High School and our community are better places because of the Bedford Community Stadium.

The Bedford High School Hall of Fame is a project of ours that we are extremely proud of. We began in 2000 with our first induction ceremony as a way to enshrine those who have contributed significantly to the pride and tradition of Bedford High School. The annual Hall of Fame Banquet has been recognized as one of the most prestigious events of the year in Bedford.

In the past we have offered two scholarships annually, but lack of funding this past year caused us to withdraw them for the year. When the stadium debt is retired, working toward an endowment scholarship fund is our next goal. Helping kids at Bedford is one of the primary reasons that we should even have an Alumni Association. We also participate in the "Adopt-A-Road" program sponsored by the Monroe County Road Commission. Our association adopted the two mile section of Dean Road between Lewis Avenue and Douglas Road.

Over the years we have hosted many fundraising events to help our cause: Spaghetti Dinners, Reverse Raffles, Stadium Brick Sales, Candy Bar Sales, and basketball games between the staff of Bedford Public Schools and the TV-13 All Stars are just some of the things we have done to raise funds for the organization. We also became an Internal Revenue Service recognized 501- C-3 charity in 2004 to make donating to the organization more appealing and easier for our donors. We have also been an active member of the Bedford Business Association and have staffed a booth at our local trade fair for many years as well.

We continue to work diligently toward meeting our financial obligation to the stadium payment each and every year. With the economy being a little soft, donations and fundraising has been difficult. It is our plan to continue working hard, ride out the soft economy, and then be prepared to take the association forward in a positive direction toward doing more for the students of Bedford High School. We continue to strive to provide excellent service to our Alumni, whether it is finding a lost classmate, speaking at a class reunion, or conducting a tour of the school and facilities. It is a labor of love for those of us who are actively involved.

# The Bedford High School Alumni Association Constitution

Revised 4-12-2000

# Article I-Name

The name of the organization shall be *The Bedford* High School Alumni Association.

# Article II-Mission/Purpose

The purpose of the Bedford High School Alumni Association ("Association") shall be to a.) Continue the camaraderie of graduates of Bedford High School ("School") and those interested in the future and well being of the School, b.) To provide support (financial assistance or otherwise) for causes deemed worthy by the members of the Association, and c.) To keep members informed of the status, accomplishments, and/or significant events of the School.

## Article III-Membership

There shall be two (2) classes of membership:

- a.) Alumni Members: Persons who graduated from Bedford High School.
- b.) Associate Members: Persons who express an interest in perpetuating the well-being of the School.

Membership shall become active immediately upon receipt of application.

# Article IV-Officers

President Vice-President Secretary Treasurer In case of a vacancy, the executive board has the power to appoint an individual to fill a term until the next regular election.

### Article V-Dues

Dues, if any, shall be established by the Board of Directors and voted on at a regularly scheduled meeting.

### The Bedford High School Alumni Association Constitution Page Two

# Article V - The Board of Directors

The Board of Directors ("Board") shall consist of all officers plus two (2) members in good standing elected at large each year.

### Article VI – Committees

The Association shall consist of the following standing committees to be chaired by members in good standing and appointed by the Board:

- 1.) Membership Committee
- 2.) Fund Raising/Endowments
- 3.) Student Relations
- 4.) Alumni Relations
- 5.) Special Projects

Other committees shall be formed by the Board when deemed necessary and shall also be composed of members in good standing.

# Article VIII – Authority

The Rules contained in *Robert's Rules of Order; Revised* shall govern the Association when they do not conflict with the Constitution or by-laws of the Association.

### Article IX – Amendments

The Constitution and by-laws may be amended at the recommendation of the Board of Directors by a vote of  $\frac{3}{4}$  of the members present at a regularly scheduled meeting.

Alumni Association Procedures and Responsibilities (Revised August 2015)

**Responsibilities of Alumni Association officers:** 

1. President:

a. Will be the official spokesman for the Alumni Association

b. Will prepare the Agenda for all meetings and provide a copy to the Alumni Association secretary at least a week before the scheduled meeting so the secretary can notify the other officers and the membership.

c. Will preside over all meetings.

2. Vice President:

c. Will be responsible for writing thank you letters for all donations to the Association.

#### 3. Treasurer:

a. Will be responsible for all deposits and payments for the Association.

b. Will pick up all mail on a weekly basis from the mailbox at the BPS Administration office.. The treasurer will leave mail in an envelope marked for the President, Vice President or Secretary.

c. Will be responsible for all accounting procedures for the Association.

d. Will prepare financial reports for each membership meeting.

4. Secretary:

a. Will be responsible for recording the minutes of all meetings and provide those minutes at the next Association meeting.

b. Will make available the meeting agenda to all officers and members at least one week before all meetings.

c. Will be responsible for all correspondence that is delegated to her/him by the President.
