Board members asked questions, and thanked Mr. Renius for his presentation.

# APPROVAL OF CHANGES TO PLANNING/ZONING & BUILDING FEE SCHEDULES

Jenkins presented this request, outlining the various changes. The change to the building fees would allow the department to charge a \$25.00 registration fee for each roofing job a company does, rather than an annual fee of \$25.00, further protecting the homeowner and township. The change to the planning fee schedule would allow mileage and inspections carried out as part of an approved site plan to be deducted from the applicant's escrow account rather than being paid out of the general fund. Motion was made by Goebel, seconded by Hurley to approve the changes to the Planning/Zoning & Building Fee Schedule, after removing the wording "reroofing annual registration fee" to read "reroofing fee" on the forms. # LEWIS AVENUE BETWEEN AA RAILROAD CROSSING AND PICKARD ROAD

Wilburn spoke, explaining this contract would pay for design costs of \$5,000.00 for road improvements at Lewis Avenue between AA railroad crossing and Pickard Road, and the construction/project engineering costs to be funded 100% by ARRA "Stimulus" Project/Future Aid Project monies if they become available. Motion was made by Hurley, seconded by Goebel to approve the MCRC contract for design costs of \$5,000.00 for road improvements to Lewis Avenue from AA railroad crossing to Pickard Road, as presented. # BEDFORD PORTION OF STERNS ROAD BETWEEN US-24 & M-125

Wilburn spoke, explaining this contract would pay for design costs of \$1,500.00 for road improvements on the Bedford portion of Sterns Road between US-24 and M-125, with the construction/project engineering costs to be funded 100% by ARRA "Stimulus" Project/Future Aid Project monies if they become available. Motion was made by Goebel, seconded by Hurley to approve the MCRC contract for design costs of \$1,500.00 for the township's portion of road improvements to Sterns Road between US-24 & M-125, as presented. Motion carried on a roll call vote as follows: Aye: Francis, Meyer, O'Dell, Schockman, Goebel, Hurley, & Wilburn. Nays: None. Absent: None.

# **VARIOUS PRIMARY ROADS**

Wilburn spoke, explaining this contract would pay for design costs of \$3,500.00 for road improvements to various primary roads in the township, with the construction/project engineering costs to be funded 100% by ARRA "Stimulus" Project/Future Aid Project monies if they become available. Motion was made by Hurley, seconded by Goebel to approve the MCRC contract for design costs OF \$3,500.00 for overband crack fill on various primary roads in Bedford Township, as presented. Motion carried on a roll call vote as follows: Aye: Francis, Meyer, O'Dell, Schockman, Goebel, Hurley, & Wilburn. Nays: None. Absent: None.

### **PUBLIC COMMENT**

Joyce Beech, 3222 Consear Road, commented on problems with excessive noise from a restaurant/bar near her home, then provided the board with a written handout.

Frank Knoll, 2595 Chapel Creek, read letter to the board, explaining the repair process for local subdivision roads.

Nancy Tienvieri, 3962 Coachman, questioned the boards recent approvals on road issues.

### REPORT FROM TOWNSHIP BOARD MEMBERS

Hurley – Mentioned she had been to Lansing with the Senior Citizen's group, and Bedford was well represented. Hurley also informed the board that Senator Richardville was in Bedford today, discussing issues with senior citizens.

Goebel – Mentioned the budget and budget cuts made for the 2009-10 fiscal year, and invited residents to attend the fireworks display on July 31, 2009.

O'Dell – Thanked Mr. Renius for his presentation on Proposal A.

Francis – Commented on the noise ordinance issue and road improvement issue, and suggested an article in newsletter explaining budget issues.

Meyer – Stated tax bills have been sent out, and reminded residents if they had not received theirs or if they wished to apply for a deferment to contact her office.

Schockman – Spoke regarding special assessments, and stated this information has been in the newsletter and newspapers in the past and will be published again.

Wilburn – Thanked everyone for their comments, and spoke to the noise and road improvements issues that were mentioned in public comment. He also mentioned the sewer line that is being installed from the Secor/Smith intersection south to the Ohio Michigan line, and the traffic problems occurring at that site.
