#### APPROVAL OF ST. GERMAIN REZONING FROM R-2A TO PBO

Jenkins informed the board this request for a zoning change on parcel no. 58-02-031-091-00, 6801 Secor Road, was formerly the site of a day care center and originally the site of Rawson School. He further stated the request is consistent with PBO zoned property to the south and west of this site, and has been approved by both Bedford Township Planning and Monroe County Planning Commissions. Motion was made by Meyer, seconded by Goebel, to approve the rezoning request for 6801 Secor, parcel no. 58-02-031-091-00, from R2-A to PBO (Professional Business Office), this request being consistent with the PBO zoned property located south and west of the site, as approved by Bedford Township Planning at their August 12, 2009 meeting and by Monroe County Planning at their September 9, 2009 meeting. #### APPROVAL OF FAMILY MEDICAL CENTER REZONING FROM RME TO PBO

Jenkins spoke, explaining this requested rezoning change on parcel no. 58-02-022-044-10 and a portion of 58-02-022-004-30, 8765 Lewis Avenue, will enable the Family Medical Center to expand their facility. It is considered compatible with adjacent zoning, and was approved by both Bedford Township Planning and Monroe County Planning Commissions. questioned the flood plain issue, and Jenkins explained the property is in a 100 year flood plain and this issue would be addressed at the time the site plan is submitted. Motion was made by Meyer, seconded by O'Dell to approve the rezoning request for Family Medical Center, located at 8765 Lewis Avenue, for property no. 58-02-022-004-10 and a portion of 58-02-022-004-30 from RME (Elderly Housing Residential) to PBO (Professional Business Office) to allow for expansion of the medical facility, as approved by Bedford Township Planning at their August 12, 2009 meeting and by Monroe County Planning at their September 9, 2009 meeting, for the reasons given in the May 13, 2009 Planning Commission minutes that it would be consistent to adjoin with existing PBO and is compatible with adjacent zoning, in addition, the parcels shall be combined prior to any building constructed on the site.
