

Request for rezoning of a land area comprised of approximately 19.57 acres zoned R-2A, Single-Family Residential and C-2, Shopping Center Business District to C-3, General Business District, all of which is situated on a portion of a parcel containing approximately 41.71 acres.

The portion of the 19.57 acre land area zoned R-2A, Single-Family Residential currently allows PBO, professional and business office uses in an area situated in the Southwest corner of said land area by order of the Monroe County Circuit Court.
