An owner or party in interest, or his or her agent may appear in person at the hearing to protest the special assessment, or may file his or her appearance or protest by letter and his or her personal appearance shall not be required. If a special assessment is made against property, the owner or any person having an interest in the property may file a written appeal of the special assessment with the Michigan State Tax Tribunal within thirty (30) days after the confirmation of the special assessment roll if the special assessment or special assessment roll was protested at or before the first or

second public hearing.
